In case of payment default and attorney engagement, the Applicant liable for collection costs, including attorney fees. Fees are settled by the Applicant when incurred for consultation, trial, or appellate services. Regardless of payment location, legal suits for breach or payment default are initiated in a Court of competent jurisdiction in the relevant state. The agreement is governed by the laws of Kings County, State of NY. Both parties consent to the jurisdiction of said State. The undersigned warrants a thorough review and comprehension of the Agreement by the Applicant. Authorization is granted to Atlas to access credit and financial information at any time.

PERSONAL GUARANTEE: In consideration of Atlas Plumbing & Heating Supplies, Corp. ("Atlas") granting credit to the Customer, the Guarantor (even if multiple) hereby warrants and unconditionally guarantees to Atlas the full and timely payment, including any accelerated or extended maturity, of all debts, obligations, and liabilities of the Customer to Atlas. The Guarantor also agrees to waive all venue rights and cover any expenses, including court costs and legal fees, incurred by Atlas in attempting to recover the debts or enforce the Guarantee as outlined in the Application. Furthermore, the Guarantor waives all notifications and requests of any nature and consents to any agreements or arrangements with the Customer, including but not limited to payment, extension, subordination, composition, discharge, or release of any portion of the debts, without diminishing the Guarantor's liability. Atlas reserves the right to release or surrender any security held for the debts guaranteed herein, without absolving the Guarantor's responsibility. This Guarantee remains enforceable before, during, or after actions against the Customer, without reliance on any security. The Guarantee remains valid despite any incorporation, merger, reorganization, or sale of the Customer's business, extending to any credit granted to such entities. It shall persist until terminated in writing by the Guarantor and received by Atlas, Attention: Credit Manager, via registered or certified mail, return receipt requested. Notwithstanding termination, this Guarantee remains in effect for the outstanding balance as of the termination date, along with any accrued interest and collection costs.
